"Stewardship" included managing the 490 acre Bear River Bottoms conservation easement. Activities included planting native plants for wildlife habitat, monitoring this property and adjacent properties for weed infestations, monitoring for compliance with restrictions outlined in the easement document, managing grazing leases used to control weeds and invasive native vegetation, securing boundaries, and planning for future management. It also included working with private and public entities seeking to establish wetland mitigation projects on this easement consistent with the site management plan.

4b (Code:) (Expenses \$ 7431 including grants of \$) (Revenue \$ 1)

"Land protection" included expenses on new projects, such as establishing a new conservation easement on the shoreline of Bear Lake near Garden City, Utah; expenses, including appraisals and boundary surveys, associated with acquiring 30 acres of wetland meadow habitat supporting a threatened species of plant (Ute ladies'-tresses, an orchid listed by the U.S. Fish and Wildlife Service as "threatened" in Utah; and expenses associated with other miscellaneous potential conservation properties.
